Working on planning. FY26 allocation statewide is \$17.7 million.

**ENVIRONMENTAL QUALITY INCENTIVE PROGRAM (EQIP):** Sign up deadline extension to January 15<sup>th</sup>.

Working on planning. FY26 allocation statewide is \$31.8 million.

**MISCELLANEOUS:** Will attend the Sioux Falls Farm Show on January 28-30.

**Big Sioux River Project Report by Barry Berg:**

**SRAM & RAM:** Will be finishing a RAM project in Lincoln County and 2 SRAM projects in Minnehaha County in February. SRAM manuscript for journal publication through SDSU.

**EQIP/RCPP:** No update

**OTHER RELATED ITEMS:** Finished 2 alternative water projects. Next Big Sioux River Project Steering Committee meeting is March 17<sup>th</sup>. Attending Sioux Falls Farm Show on January 28-30. MSP to approve Voucher 30 in the amount of \$69,332.45 for two alternate water projects and one RAM project by Bonander and Severtson. All ayes. **Urban Educator Report by Alina Krone-Hedman:**

**OUTREACH: Good Earth Christmas Tree Decorating** took place on December 9<sup>th</sup> with approximately 15 local groups. Tree was taken down on January 5<sup>th</sup>. **Sioux Empire Water Festival** – March 2-4. Always need more volunteers.

**CITY PARTNERSHIP: Prairie and Pollinator Program, Demonstration Gardens and Community Garden and Education Demonstration Area** - Planning for spring.

**GRANTS/FUNDING PARTNERSHIPS: NACD Technical Assistance Grant** – Received partial payments from NRCS of requested fund reimbursements. Working on continuing planner training. **2026 NACD Technical Assistance Application** – Application was submitted for January 8<sup>th</sup>. Anticipated funding notification by end of March 2026.

**OTHER: MCD Newsletter** – In design stage and hoped to be sent to printer by next week. **Soil Health Coalition** – Working to finish up signs/Gevik site improvements. **Conversations & Conservation** – Postponed from December 11<sup>th</sup> to January 8<sup>th</sup> at 5:30 p.m. at Fernson Brewery on Robur. Several people joined. Another is anticipated to be planned in early spring.

**Public Comment Time – 15 minutes**

**Heisey** mentioned that he was appointed as the County Commission Liaison to the Minnehaha Conservation District again for 2026. He invited the board to bring any concerns to him. He said the commission is planning 5-30 years into the future. They are looking at the need for more office space. He also talked about issues coming up in the legislature this year, including data centers and property tax.

**Update from Supervisors – Entenman** mentioned that he moved into Lincoln County recently. He would like to stay on the board as an advisor. He was accepted into the NACD national leadership program. He will attend the national NACD convention in San Antonio next month. He will attend the SD Tourism Conference in Pierre next week, and the SD Grassland Initiative Summit in March in Mitchell. He will give an update about conservation districts at that event. **Heber** mentioned the Research Farm Focus Group meeting (to get feedback for the ARS Research Lab) on January 21<sup>st</sup> from 12:00 – 2:00 p.m. in Brookings. He will also participate in the Research Farm delegation trip to Washington D.C. in the first week of April. They have an April 2<sup>nd</sup> meeting with USDA representatives. He will attend the March 18<sup>th</sup> Annual Meeting at the Research Farm in Brookings.

About 2200 students and 120 teachers. \$27,500 in donations so far for this year. About 20 presenters were enlisted.
