Bio-solids: 5-year deep soil samples will be collected. **Trees**: Survival count starting this week. Working on tree plans for next year. **Grass**: More planting to do in the next week. Positive results this year. **Gevik Site**: Signs for the trails should be printed soon. The power source issue for the kiosk should be resolved soon. Will be working on fixing the trail.

Spraying and mowing are completed, with some shelter belt cleanup to do.
